Fullerton submitted several first-stage program requests, and a correction was noted for Program #7 (Baking & Pastry Foundation Certificate of Achievement) updating the TOP code from 1306.00 (Nutrition Foods and Culinary Arts) to **1306.30 (Culinary Arts)** to better align with CIP and SOC codes; this change will be reflected in the meeting minutes. With the TOP code phase-out underway, Ms. Dorsie Brooks requested that CIP codes be included alongside TOP codes in reports, and the OCRC team confirmed this adjustment will begin with the September list. The group also discussed duplication concerns, with Mr. John Jaramillo emphasizing the importance of considering local duplication in labor market information (LMI) reviews to ensure program supply does not exceed job demand. Dr. Jesse Crete clarified that while CSU/UC duplication is addressed in the application process, the consortium's role is to review and recommend programs to streamline approval. For baccalaureate programs, supply analysis differs since most community colleges do not yet have such offerings, and current data reflects four-year institutions or recently approved programs not yet producing graduates. Members reviewed LMI reports, which should be assessed for educational level appropriateness, living wage outcomes, and supply-demand gaps. As more baccalaureate programs emerge in overlapping fields, supply gaps may narrow, and members were reminded to raise concerns if new proposals could impact existing programs. Informational items will continue to be shared in advance to allow for regional discussion prior to recommendations, and members are encouraged to contact program leads directly with alignment or impact questions.

VI. Update, Discussion, and/or Action Item

- a. Baccalaureate Degree Program Discussion**

Ms. Dorsie Brooks, Golden West College

- Ms. Dorsie Brooks shared that, in conversations with colleagues and industry partners regarding baccalaureate programs, she identified an advocacy issue related to the student-centered funding formula. Currently, community colleges do not receive the transfer completion metric when students transfer to another community college's baccalaureate program, such as Santa Ana's upcoming automotive program. She emphasized the importance of addressing this gap as baccalaureate offerings expand, noting that transfer recognition would better support student mobility and college funding, particularly in tighter budget years. Mr. John Jaramillo suggested working through CCCAOE, which has successfully advanced similar legislative changes in the past, in collaboration with groups such as the Statewide Academic Senate. Ms. Elizabeth Arteaga confirmed she could elevate the issue to CCCAOE with a formal request. Ms. Brooks committed to sending the request and engaging her college president and district chancellor to build broader support.

VII. College Updates

- a. Coastline:** Submitted 2 baccalaureate programs last week.
- b. Golden West:** Ms. Dorsie Brooks reported that Golden West has been busy with curriculum work over the summer. The college will be recruiting for a permanent Nursing Associate Dean/Director position in the fall, with an interim currently in place. Additionally, new full-time faculty have been added in Automotive and Cosmetology, with the latter already on board. Enrollment trends appear positive, though some challenges with automated bot activity persist.
- c. Saddleback:** Mr. John Jaramillo reported that Saddleback recently opened new culinary and automotive facilities at ATEP in Tustin, highlighting their exceptional quality and design, with future opportunities for visits planned. He noted the retirement of Dean of Health Sciences, Sherry Lowen, and announced that Rebecca Orozco, former Director of Nursing, will step into the role, with a search for a new Nursing Director expected. The college will also recruit for several permanent positions this fall, including lab technicians, management roles for the new facilities, and a re-opened search for an automotive faculty position. Additionally, Saddleback is working with regional partners to host an automotive education conference in October.
- d. Santa Ana College** shared several updates. Mr. Matt Valerius was appointed Dean of Human Services and Technology, with Mr. Refugio Rodriguez stepping in as Associate Dean of Career Education and Dual Enrollment. The college celebrated a ribbon-cutting for its new Paralegal Studies bachelor's program, which launched this fall with 41 students and already has 16 enrolled for spring. Early wage data from Equifax shows CTE certificate holders significantly out-earning associate degree graduates, with paralegal certificate completers averaging over \$80K five years post-graduation. Mr. Anthony Pagán highlighted strong student services support in launching the program and called for regional collaboration on articulation agreements to better align associate and bachelor's pathways. He also noted additional baccalaureate programs in occupational therapy and forthcoming proposals in the business division. Ms. Dorsie Brooks suggested leveraging the OC Deans biweekly meetings to engage articulation officers and formalize these discussions across the region.
- e. Santiago Canyon:** Ms. Elizabeth Arteaga announced that Dr. Denise Foley is now the permanent Dean of Business and Career Education. Dr. Foley reported that the college submitted its Applied Water and Wastewater Technology bachelor's degree and is awaiting final approval on the long-pending Digital Location Information Sciences application. She also highlighted progress in addressing fraudulent enrollment activity, noting that SCC partnered with N2N and Admissions & Records to successfully mitigate bot-related issues that had heavily impacted the college last fall. By this semester, the system has significantly improved, ensuring cleaner rosters and access for genuine students.
