During the review of the Medical Laboratory Technician Baccalaureate proposal, members raised concerns regarding the program title. It was noted that the term "technician" typically applies to two-year degrees, whereas "technologist" or "scientist" is more appropriate for four-year degree programs. COE confirmed that they had previously provided similar feedback and expect a title change to be reflected in upcoming materials. Saddleback College is currently reviewing naming options, including "technologist" and "scientist," to better align with industry standards and differentiate the program. Final title determination will occur before the final report is issued, likely in the next month. The advisory group will play a key role in shaping the final decision.

There was clarification that under the Chancellor's Office's updated process, the region provides a recommendation, not an approval, as part of the state application. The regional review focuses mainly on labor market information, while duplication analysis with CSU and UC is handled at the state level. Some members expressed concerns about the potential for overproduction, noting that one college submitted two similar cyber programs with the same TOP and CIP codes. There was also discussion about CSU and UC increasing their activity in launching AI-related bachelor's degrees, highlighting the importance of strong employer engagement and timely submissions. Colleges planning to submit by the January 15 deadline were asked to notify COE as soon as possible because of the workload and the significance of labor market data in the application scoring.

VIII. College Updates

- a. Coastline: Andrea provided a brief update on upcoming regional workforce project events. An AI convening will take place on October 4, with college students, upper-level high school students, and educators as the intended audience. A flyer has been shared with the group, and members were encouraged to reach out with any questions. In addition, the quarterly AI project meeting is scheduled for tomorrow to share updates from partner colleges, and colleges funded under the project were asked to ensure a representative attend.
- b. Cypress: An upcoming event focused on Career, Job Readiness, and AI Impact is being planned for late October at the Marriott in Irvine. The primary audience will include ROP students, along with community college faculty, staff, and administrators. The event will highlight Orange County industry partnerships, aiming to connect students with internship and employment opportunities through boot camps that build relevant skills. Industry partners will be invited to share the skills they look for when hiring. A planning committee has been formed, and details will be shared with colleges as planning progresses. All colleges will be invited to participate.
- c. Golden West: Dorsie shared that a new initiative is underway focused on community college to community college baccalaureate articulation using \$325,000 in available funding. Santa Ana College will lead the effort, which aims to create a structured work group and provide resources for faculty to strengthen transfer pathways into existing community college bachelor's programs. The initial focus will be on Occupational Health, Automotive Technology (both at Santa Ana), and Dental Hygiene, exploring how associate degree pathways can better align and support student transitions. This work will also help lay the groundwork for future legislative efforts to ensure the student-centered funding formula recognizes and rewards these transfer pathways.
- d. Fullerton: Fullerton College shared updates on upcoming events for Manufacturing Month in October. Manufacturing Day will take place on October 10 and will involve several high schools and possibly middle schools. On October 24, the college will host a Metrology Event sponsored by Hexagon, featuring breakout sessions on measurement technology and its applications, including AI. The event will conclude with a social gathering at Madero. Fullerton highlighted how metrology, the science of measurement, is integrated across multiple programs including civil engineering, crime scene investigation, and manufacturing. These applications demonstrate the technology's importance across various industries. Exhibits will also showcase how this technology is being applied throughout the curriculum.
- e. NOCE: Kim Tang from North Orange Continuing Education shared that she has stepped into the Associate Dean role as of July 1, following Tina McClurkin's return to her full-time faculty position. She officially introduced herself and expressed her enthusiasm for working more closely with the group and becoming more involved in the program recommendation process.
- f. Orange Coast: Orange Coast College shared two key updates related to the Bridge to the Workforce program. First, the program officially launches today with an open house at the Career Center in Watson Hall, starting at 11 a.m. Project leads and interested partners are invited to attend, network, and learn more about the center's services. Second, the college will host its first Career Showcase event on October 9, featuring employer panels, career exploration activities, and recruitment opportunities. The event is co-sponsored by the Orange County Workforce Development Board and District 5 County Supervisor Katrina Foley. Flyers are available, and all colleges are encouraged to participate.
