- i. Dr. Marcia Wilson reminded the group to make sure the programs are being reviewed. She added that if anyone has similar programs, or would like to be helpful to the colleges that are developing the programs, or to see ways to make sure that if there is alignment, to reach out to those colleges. There is also an expectation from the colleges developing the programs to reach out.
- ii. Dr. Marcia Wilson mentioned that there are two modified programs:
  - a. IT Desktop and Server Operations, Santa Ana College
  - b. IT Support Specialist, Santa Ana College
- iii. Dr. Marcia Wilson continued by asking if the modifications for short-term certificates or locally approved certificates that are now going to be full certificates, or if there will be any other types of modifications.
- iv. Kimberly Matthews answered by stating that they are certificates of proficiency. They are local certificates that are now going to become certificates of achievements. She added that they were included on the June Agenda for informational items, as the request went out to COE.
- v. Marbella Ruiz confirmed that the request for program data was sent out to COE, and it was an error to list the programs as modified. The faculty who originally submitted the programs, selected "Substantial Change" instead of "New Program"; however, Lupe Aramburo, sent out a revised agenda with the corrections reflecting these programs eligible for recommendation.

#### I. Action Items

Dr. Marcia Wilson, CRLC Chair and Dean Resource Associate Chair, LAOCRC

- i. Dr. Marcia Wilson asked for clarification in regards to the programs that were added to the list of eligible programs for recommendation programs listed from 10-12.
- ii. Marbella Ruiz clarified that per the previous discussion, Lupe Aramburo, sent out the revised December Agenda reflecting the corrections, where programs listed from 10-12 were added from Santa Ana College.
- iii. Kathleen Reiland abstained on the Nutrition and Foods Skills Certificate. She added an advisory, that Cypress has the hotel restaurant culinary program, and advised Mr. Ken Starkman that Fullerton's "Nutrition and Foods Specialist" program looks okay; however, it seems to be moving towards culinary, which is a program that Cypress College would not like to compete in.
- iv. Nancy Jones voted "No" on the three programs Santa Ana College submitted, IT Desktop and Server Operations; IT Support Specialist; and, IT Network and Security Operations. She

- also noted that her concern is with the classes in Santa Ana College. There is no issue with the programs themselves; however there has not been any collaboration, though close proximity to Coastline Community College. It is important that faculty at both colleges have a discussion, and that has yet to take place.
- v. Kimberly Matthews apologized to Nancy Jones, and advised that she will reconnect with Santa Ana College faculty, and have them connect with Coastline Community College faculty.
- vi. Nancy Jones responded that she is not opposed, but there needs to be a discussion so that there is no duplication.
- vii. Dr. Marcia Wilson indicated that because the original motion was to recommend the programs, the four items in question will be pulled for discussion to note the abstention and the "No" vote.
- viii. Carmen Dones mentioned that a vote had already been made.
- ix. Dr. Marcia Wilson responded that if proceeding with the original vote, the abstention and "No" vote apply to all of the programs. The items should have been pulled for discussion in order to stand alone with an abstention and/or vote.
- x. Kendra Madrid mentioned that the programs eligible for recommendation are listed on the agenda prior to the meeting for review, and added that it would have been best to have contacted the college with programs in question, prior to the meeting.
- xi. Nancy Jones responded with stating that she had previously asked that Santa Ana College faculty reach out to Coastline Community College; however, that has yet to happen.
- xii. Larisa Sergeyeva, stated that she cannot speak on behalf of the cyber security since that is in the business department; however for culinary, there is new faculty and mentioned that she is the new Dean and they are more than happy to collaborate and sit with Nancy Jones to discuss.
- xiii. Nancy Jones clarified that she does not have a problem with culinary as Coastline Community College does not have culinary.
