#### **Dance Teacher Certificate**

### 1. Program Goals and Objectives

"A dance teacher communicates theory and practice of any one of a number of dance disciplines to students. Since time immemorial humankind has danced. Be it for celebration, social interaction or to express a deeper concept related to the human condition that is inexpressible through other means, dance is inextricable from our existence in the same way as music and conversation. Over time, dances have become highly complex and specialized, often taking years of training in order to reach an intermediate level; other times they are simple and to be enjoyed as part of a group celebration. We rely on dance teachers to show us the steps and begin to bring out the potential in our bodies. With a greater emphasis on personal development and more leisure time than ever before, more and more people are turning to dance classes as a means of keeping fit, meeting new people and discovering more about themselves."

Mt. San Antonio College offers a multitude of dance courses but does not offer an official certificate. The primary goal of the program is to offer a series of coursework that will culminate in a certificate that prepares the student to compete for dance instructor positions.

In addition, a Dance Teaching Method course was created and will integrate with the existing dance theory and technique classes. Students completing this certificate will be able to demonstrate skills in the following categories:

- Classroom management
- Effective communication
- Organization and problem solving
- Dance pedagogy
- Dance composition and choreography
- Elements of concert production
- Real-world experience
- Kinesiology
- Dance theory and technique
- Dance history

# 2. Catalog Description

The Dance Teacher Certificate is intended to prepare students for careers as dance instructors in private dance studios, recreation centers, and K-12 dance programs. Focus is on the genres of Ballet, Jazz and Modern Dance with pedagogical principles that can be applied to other dance forms. This certificate will aid the student's search for an entry-level job in the dance teaching world.

#### 4. Master Planning

# The dance department determined that the certificate should be offered based on the following:

This Dance Teaching Certificate will be included with the existing certificates of achievement at the college and is designed to prepare students for teaching careers in dance studios. The certificate is consistent with the mission of the college in the area of Career and Technical Education (CTE). Dance teaching is a well-established vocational discipline which was established in the 1500's. It is a viable career in the private sector, the secondary level and the post-secondary level. The popularity of dance has increased over the past several years with the growth of television dance programs, dance films, and regional and national dance competitions which have increased the demand for more dance instruction. Dance teaching is relevant in performing arts and kinesiology programs. In 2012, the Dance Advisory Committee recommended the development of the Dance Teaching Certificate.

# 5. Enrollment and Completer Projections

Mt. San Antonio College offered the capstone class, Dance Teaching Methods in the Spring of 2012. With very little advertising for the Dance Teaching Certificate Program, the class still met the course limit of 20 students. Based on this enrollment data and informal surveys of existing dance students, the dance department estimates that the Dance Teacher Certificate enrollment to be from 20-30 students per year.

Due to the competition for dance teaching positions, the program must be rigorous enough to prepare students with the needed knowledge, skill and experience to compete successfully. Therefore, we estimate a completion rate of 50% or 10-15 students per year.

### **B.** Employer Survey

A detailed Dance Teacher Survey was conducted in August of 2012 and again in September 2013 (see attached) among 25 potential employers of dance instructors. The population included 17 private dance studios, 7 high schools/performing arts schools and one community center spread throughout the Orange, San Bernardino and Los Angeles County regions. The objective of the survey was to clarify and validate jobs in the field as well as to enumerate the specific qualifications, skills and competencies needed to attain employment as a dance instructor. In addition, the survey included a space for respondents to add comments for any areas of concern not addressed in the survey. The Dance Teacher survey results indicated that:

- 96% of respondents felt that the certificate, as described, would qualify students for dance teaching positions
- 92% of respondents felt they would preferentially hire a student with a certificate over a candidate without a certificate.
- Over 50% of the respondents predicted hiring an average of 3-4 new teachers each year and an average of 10 within a five year period
- 96% of the respondents predicted hiring more than 2 new teachers each year

Positions included dance instructor, choreographer, program director, teaching assistant and assistant coach. Many survey respondents required competencies in professionalism, choreography, classroom experience, musicality, classroom discipline skills and creativity. These requirements are covered in the proposed curriculum for the Dance Teacher Certificate. In addition, respondents indicated that they overwhelmingly supported the certificate and felt it would be highly beneficial in educating and preparing students for the demands of teaching dance.

3. Do you believe the Dance Teaching Certificate as described would qualify students for the specific positions?

Yes (5 respondents)

Absolutely. I feel like a program such as this gives future instructors a better insight. Yes. The teaching certificate will better prepare someone to fill these positions. I feel this program would help to better equip someone to teach. Yes! This would really give them practical experience – teaching in different environments.

Yes – especially for younger students.

Yes, it will prepare students to be better staff.

Absolutely. The dance studio world needs a program like this where we know the teacher has an educated teaching background, not just training.

Yes – I recommend it whenever someone inquires about how to get a job as a dance instructor.

Absolutely!

Yes, absolutely.

Yes, we also do tap instruction so that is the only area currently lacking for my program. Yes! It would be great to know I'm hiring candidates who have been trained in the art of teaching dance, much like public school districts only hire credentialed teachers who specialize in a specific field of study. Dance studios often hire dance teachers based on their performing experience, but I would much rather hire teachers who have been trained in dance pedagogy, classroom management, best teaching practices, etc. I see a Dance Teaching Certificate program much like any other certificate program in other fields—it proves the candidate has met the program requirements and is likely prepared for a role in that field.

Absolutely. We just hired a dance instructor who is going through the Program at Mt. SAC and are very happy with him. It helps to have the educational background and hands-on experience that the Dance Teaching Certificate provides. There are a lot of people who claim to be "dance teachers" without the proper training or experience. The Dance Teaching Certificate provides credibility to the applicant.

That would be a wonderful way to hire young adults and know that they have the proper training to work with high school age students.

Yes, potential instructors need classroom training along with hands-on training. Yes but under the stipulation that besides having classroom knowledge, practical experience and an apprenticeship would be beneficial.

I believe wholeheartedly the Dance Teaching Certificate described would qualify students for specific positions within a dance department. Choreographers and teachers need professional training such as this in order to adequately prepare them for demands that accompany the role of a choreographer and the diverse settings they will encounter.

Dance training/placements and correct warm-up, exercises, body awareness, physical rigor, proper attention to injury prevention, etc. would be a step up for all teachers! I do believe that the certificate would help a great deal in students qualifying for specific positions, yes.

Yes. School districts in California require a fully credentialed certificate from a university plus a minor in Kinesiology.

Yes, but I would also need to see the instructor teach before I could hire them.

#### 4. Would you preferentially hire students who have completed the program?

It would give them an upper hand if I were looking at their resume versus an instructor who was not certified.

Yes! I am always looking for teachers who have a background in dance education as well as dance technique and performance. As a high school teacher, I encourage my dance students to continue their education after high school, with the hopes of

continuing to study dance at the collegiate level. The Dance Teaching Certificate is an excellent program for students who are looking to continue their dance education.

Yes. (10 respondents)

It would give us the confidence of our decision to hire them. A teacher with this certification would get them to the front of the line of consideration.

Yes, it would be a plus!

Knowing students completed this program would be a major plus and make me feel confident about their experience.

Although I do believe that the program is great for future instructors, I'm not sure I'd use the term "preferentially hire."

Yes. Our conservatory hires or prefers to hire instructors either with degrees (min. BA or BFA in dance) from a reputable college or university.

Yes!! Mt SAC does a great job!

I would consider all applicants and interview and observe them in class as well.

Yes, absolutely I would.

I think it would be beneficial to my program to have these well-rounded serious-minded people on my staff. If they have to complete the program, then I know they are invested in this line of work.

I would definitely prefer to hire students who have completed a program such as this because completion of this program would give me confidence that the candidate would be able to meet the demands of the job.

Yes, any type of degree or certificate is a plus along with performance and teaching experience.

Yes, I would prefer to hire students with a certificate in this program.

#### Additional Comments:

A knowledge in basic anatomy and kinesiology would be helpful. Some sociology and psychology courses would help as well. Practical experience is significant as well. I would rather hire somebody with the certificate, it better prepares them for this industry.

Choreographic integrity and reliability are a couple characteristics I value as a High School Dance Advisor. Other topics to cover might be Technology and Dance, Music Editing, Facebook, YouTube, Video, etc.

Training in child development, knowledge of teaching young kids dealing with different personalities. Responsible and dedicated to the job!

As the above stresses, attitude is everything. Treating students with respect and teaching with firm constructive criticism as well as pointing out growth and improvement. It is a positive energy in instruction that for me has made a difference. I think hands-on correction is extremely important in all training but especially with the younger dancers. Ability to handle parents is a huge plus.

Enjoys working with children or able to teach to a large group for non-progressive multilevel classes.

The certificate would give potential employees an upper hand.

For the past four years, I hired students that are pursuing high level education in the field of dance. This is becoming increasingly difficult to find. I am looking for a quality program that can train students to work in the school system. I am very interested in seeing this type of program grow so that I can build a partnership and a place for these students to get some hands-on experience. It would be a great situation for both programs.

They will also need a Kinesiology degree for credentialing in CA and Chaffey District (specifically).

Ultimately, we look for an individual who has the education, training, integrity, classroom management skills, and people skills that it takes to conduct a fun yet challenging class. Our students' safety is a primary concern. It is also important for the students to connect with their instructors. It keeps them coming back because they are motivated to learn. Teachers are also mentors.

It sounds as if this is a really great program that can easily become a state or national model! I think a "student teaching" piece would be extremely beneficial to add if it's not already included in the program's requirements. A student teaching requirement would allow "master teachers" to observer and take notes about the student teacher that could be included in the student's portfolio, resume, and recommendation letters. It would also help students network with established professionals.

#### Semester 1 (9.5 units)

DN-T 20 - History and Appreciation of Dance:

Survey of Western Civilization

(3 units)

History of dance in chronological sequence emphasizing the cultural background and historical development of various forms and styles of dance to include discussion of the influence of dance on other art forms.

DNCE 2B - Ballet II

(1 unit)

Intermediate technique, vocabulary and movement combinations of ballet. Students who repeat this course will improve proficiency through continued instruction and practice.

DNCE 12B - Modern II

(1 unit)

Intermediate technique and movement combinations for modern dance. Students who repeat this course will improve skills through further instruction and practice.

**DNCE 33 - Improvisation** 

(.5 units)

Provides the opportunity to experience the creative process of improvisation in dance and choreography. For all levels of Modern Dance. Students who repeat this course will improve proficiency through continued instruction and practice.

DNCE 35 - Repertory

(2 units)

Provides the opportunity for the advanced dancer to learn choreography and to perform repertory pieces at workshops and special events. Students who repeat this course will improve skills through continued instruction and practice.

# DNCE 39A - Alignment and Correctives

(.5 units)

Based on exercises and concepts developed by Joseph Pilates. Includes basic mat work, floor, special conditioning exercises and body awareness resulting in improved alignment, strength, flexibility, control, coordination and breathing. The mat work leads to apparatus work (on the professional reformer) emphasizing stretch, strength and trunk stability and alignment. Students who repeat this course will improve skills through continued instruction and practice.

DNCE 18A - Tap I

(.5 units)

Presents basic tap technique, rhythms and routines for tap dance. Students who repeat this course will improve skills through continued instruction and practice.

#### DNCE 11A - Social Dance Forms I

(1 unit)

Designed to teach basic social dance techniques. Focus on fundamentals of music, dance positions, dance formations and choreography to be used in the study of, but not limited to Swing, Waltz, Foxtrot and Tango. Students who repeat this course will improve skills through continued instruction and practice.

#### Semester 2 (9 units)

#### DN-T 38 - Dance Teaching Methods

3 units

The application of pedagogical methods in Dance. Explores teaching strategies, imagery, motivational techniques, music for class instruction, and injury prevention. Focus is on the genres of Ballet, Jazz and Modern Dance. Course will involve on- and off- campus dance teaching observations.

#### DNCE 4 - Choreography

.5 units

Designed for the experienced dancer to learn the techniques of choreography. Presents basic choreographic forms and compositional design. Students who repeat this course will improve technical and compositional skills through further practice and instruction.

#### DNCE 24 - Dance Production

1.5 units

Designed for the experienced dancer to apply previously learned choreographic skill, to conduct stage rehearsals and learn costuming techniques. Students who repeat this course will improve skills through further instruction and practice.

#### KIN 24 - Kinesiology

2 units

The study of movement as it relates to exercise and the interrelationships of body segments involved in human movement activity, actions of joints, nerves and muscle exercise.

#### DNCE 14B - Jazz II

1 unit

Intermediate technique, movement combinations and routines for jazz dance. Students who repeat this course will improve skills through further instruction and practice.

#### **DNCE 34 - Dance Directives**

.5 unit

Provides the intermediate student the practical experience to assist an instructor in the creation and instruction of a dance class. Students who repeat this course will improve skills through further instruction and practice.

# DNCE 32 - Commercial Dance

.5 unit

Provides the intermediate to advanced jazz dancer the opportunity to experience the different techniques of leading commercial dancers, teachers and choreographers. Students who repeat this course will improve skills through further instruction and practice.
