Students completing an Early Childhood Associate Teacher certificate are qualified to teach in a private child development program as licensed under Title 22 of the Department of Social Services. It also fulfills the educational requirements for students seeking a California Child Development permit at the Associate Teacher level.							

## 2. Provide a brief rationale for the program.

There are several reasons we would like a state recognized Early Childhood Associate Teacher Certificate:



- 1. We have been offering this internally recognized 12 unit certificate for a several years, as it forms the foundation for all subsequent programs of study in Early Childhood Education. Since its inception, our students have earned these certificates without them being reflected on their transcript.
- 2. We have been manually documenting the number of students who complete these 12 core units. This data has been helpful to us as we seek to track our students' successes as well as rely on data to apply for various grant opportunities. Formalizing this certificate will enable us to access this data through our state tracking system.
- 3. The Early Childhood Associate Teacher certificate will be the first tier of the educational requirements to enter the workforce. These courses are required by the Department of Social Services Title 22 for all teachers working in private early childhood programs.
- 4. In order to gain employment in a publically funded early childhood education program, minimally one must possess an associate teacher permit. The 4 courses in this certificate form the educational requirement for those students seeking a California Child Development Permit at the Associate Teacher level.
- 5. This 12 unit Early Childhood Associate Teacher Certificate is embedded in our higher unit certificates as well as the AS-T degree in Early Childhood Education. It is a critical first step for students entering the field.
