Primary emphasis is to prepare the student for introductory level of recreation and leisure occupational opportunities. All students must complete at least 18 units. Course work in KIN 235 C may be waived with current Red Cross cards in First Aid and CPR at the discretion of the division. To earn a certificate, complete the required courses as listed with a minimum grade of "C". At least 50% of all course work must be completed at Cypress College.

2. Provide a brief rationale for the program.

The stated goals and objectives for this Certificate will fulfill the college's mission and curriculum offerings. The origins of this program go back to fall 2015 when we recognized the employment potential for this career field and limited



offerings by our peer institutions. At this time, according to the Chancellor's office website, search for Recreation Assistant-related programs yielded 2 completed AA degrees in El Camino Community College District in each academic year, 2014-2015 and 2015-2016.

3. Summarize the Labor Market Information (LMI) and employment outlook (including citation for the source of the data) for students exiting the program. (See PCAH pp. 85-88, 136, 147, 148, 165, 168, and 176)

Occupational Employment Projections 2014-2024 (Employment Development Department, <u>Job Outlook for California Community College Educational Programs</u>, http://www.calmis.ca.gov) indicate that recreation assistant and related occupations project moderate industry growth and job demand through 2024. The projected growth in the State of California (2014-2024), and in Los Angeles and Orange Counties (2014-2024) are summarized in the following tables. Occupations reflected in these totals are recreation and recreation assistant.

(1) Total Job Openings are the sum of new jobs from growth plus net replacements. Annual job openings are total job openings divided by the number of years in the projection period.

These findings correlate well with those set forth in U.S. Department of Labor, Occupational Outlook Handbook. Wage and salary jobs are projected to increase by about 6% over the period 2014-2024. Additionally, the labor market demand indicated in the <u>Orange County Occupational Outlook</u>, while slightly lower, offers similar results for the more limited geographic area of Orange County.
