### Perkins IV/V

**PERKINS V:** On January 23, ACTE and Advance CTE participated in a briefing on Capitol Hill hosted by the Senate CTE Caucus. The briefing, titled "Perkins CTE and How Reauthorization Can Improve Programs," discussed the law, its funding formula, uses of funds, how states are making decisions and how reauthorization could improve programs. ACTE's Public Policy Director, Alisha Hyslop, and Advance CTE's Executive Director, Kimberly Green, presented to more than 70 attendees before taking questions.

The briefing comes after the House passed a bipartisan Perkins reauthorization bill last year. Senate leaders are now in discussions about introducing their own Perkins bill. ACTE has published a list of recommendations for Perkins reauthorization, which can be found here.

ACTE continues to work closely with the Senate CTE Caucus and Senators from both parties to reauthorize Perkins and restore funding cuts to the basic state grants.

**NOTE:** With the senate now talking about introducing their own bill, the approval process should be lengthier. This will not affect the receipt of 2018-19 Perkins IV allocation.

**Quarterly Reporting** – Every quarter districts are required to report and certify their Perkins <u>Title I-C, CTE Transitions</u>, and <u>Title I-B</u> expenditures in the Year-To-Date Expenditures and Progress Report online system. The reporting schedule ensures that districts are reimbursed in a timely manner. The following reporting dates will apply for FY 2017-18.

<u>State of the System Report</u> -- The State of the System report was presented to the California Community Colleges Chancellor's Office Board of Governors at their January 2018 meeting. This reports details 6 visions for success goals for the system that are:

- 1. Increase the number of student earning credentials by at least 20%;
- 2. Increase the number of students who transfer by 35%,
- 3. Reduce units accumulated by student who complete degrees to 79;

- 4. Increase the number of student who get jobs in their field of study to 69%;
- 5. Reduce equity gaps among underrepresented students by 40% over 5 years and eliminate in 10 years; and
- 6. Eliminate regional achievement gaps in 10 years.

The report also mentions how colleges should use this vision, how the vision is related to the guided pathways framework, and additional system measurements.
